### HIGHLIGHTS

ANTAM Sales Performance for the first six month period of 2022 (1H22) booked at Rp18.77 trillion an increase of 9% from the first six month period revenue in 2021 (1H21) of Rp17.28 trillion.

ANTAM's booked unaudited ferronickel production volume within 1H22 at 11,982 ton nickel within ferronickel (TNi), with unaudited ferronickel sales volume amounted to 9,622 TNi.

In 1H22, ANTAM's unaudited nickel ore production amounted 4.39 million wet metric ton (wmt), which was used as ore feed for ANTAM's ferronickel plant as well as being sold to domestic market. ANTAM's unaudited nickel ore sales in 1H22 reached at 3.04 million wmt.

ANTAM record unaudited gold sales figure in 1H22 reached of 13,469 kg (433,038 troy oz), with unaudited production volume amounted to 673 kg (21,637 troy oz).

In 1H22, ANTAM's unaudited bauxite production volume amounted 880,618 wmt, which was used as ore feed for alumina production and as well as being sold to the third party customer. Meanwhile, the unaudited bauxite sales volume in 1H22 reached 661,266 wmt.

### **PRODUCTION VOLUME (UNAUDITED)**

### **PRODUCTION AND SALES**

During the first six month period of 2022 (January - June 2022, 1H22) ANTAM marks an unaudited revenue of Rp18.77 trillion, a rise to 9% compared to the first six month period of 2021 revenue of Rp17.28 trillion. ANTAM's gold sales commodity becomes the biggest sales contributor of Rp12.28 trillion or equal with 65% from 1H22 In 1H22, ANTAM ferronickel unaudited sales revenue.

The production and sales figures within 1H22 are generally reflected by the volatility of global economics & geopolitics tension as well as the COVID-19 pandemic approached in East Asia. A series of conditions affect the demand of based metal product absorption as well as the fluctuation of the international base metal selling price.

### FERRONICKEL

In 1H22, ANTAM's unaudited ferronickel production volume reached 11,982 ton of nickel in ferronickel (TNi), equal to 95% of 1H21 ferronickel unaudited production of 12,679 TNi.

During the second quarter of 2022 (April -June 2022, 2Q22) unaudited ferronickel production reached 6,31 TNi, grows 11% compared to the first guarter 2022 (Jan -Mar 2022, 1Q22) production of 5,681 TNi. Meanwhile, production volume within the second quarter of 2021 (Apr - Jun 2021, 2Q21) reached 6,379 TNi.

During 2Q22 ANTAM sold 3,962 TNi (unaudited) ferronickel products, a lower of 30% from the previous unaudited 1Q22 sales volume of 5,660 TNi. 

In April 14, 2022, – PT Industri Baterai Indonesia or Indonesia Battery Corporation (IBC), is pleased to announce the framework agreement singing on the development of an integrated EV Battery project between IBC with PT Aneka Tambang Tbk, PT Ningbo Contemporary Brunp Lygend Co, Ltd (CBL).
