With respect to the letter from the Indonesia Stock Exchange No.S-00500/BEI.PP1/01-2022 dated 12 January 2022 regarding Requests for Clarification on News in the Mass Media, the clarification of PT Aneka Tambang Tbk ("**ANTAM**") shall be as follows:

- ANTAM as a national mining company always committed to meet each of its obligation as a Mining Business Permit (IUP) holder, including preparing and submitting an Annual Budget and Cost Work Plan (RKAB) for each IUP owned to the Ministry of Energy and Mineral Resources (ESDM) in accordance with Regulation of the Minister of Energy and Mineral Resources Number 7 of 2020 concerning Procedures for Regional Granting, Licensing, and Reporting on Mineral and Coal Mining Business Activities.
- With regard to ANTAM's IUP in Cibaliung, Banten (IUP No. 541.23/KEP.747-BPPT/2013), currently the process of managing the RKAB is being carried out, and ANTAM is committed to submitting the 2022 RKAB before the specified deadline of 31 January 2022.
- ANTAM's gold mining IUP which is currently in active production, namely IUP (IUP No. 171/1/IUP/PMDN/2020) which is managed by the Gold Mining Business Unit in Pongkor, West Java, has received RKAB approval from the Ministry of Energy and Mineral Resources. Meanwhile, the 2022 RKAB for active IUP (IUP No. 821.13/Kep.1351-BPPT/2014) managed by ANTAM's subsidiary, PT Cibaliung Sumberdaya, has been submitted to the Ministry of Energy and Mineral Resources.
- ANTAM always prioritizes good corporate governance practices and implements good mining practice principles in accordance with applicable regulations in each of the company's business lines, including the fulfillment of the obligation to submit the Annual Work Plan and Budget as the owner of an IUP to the Ministry of Energy and Mineral Resources.
